Important Information, Limitations, Terms & Conditions

- Quality is something I greatly value, therefore I deliver high quality images and prints to all my clients.
- All Collections comes with a written wedding contract. Other important terms and conditions that are not shown here, will be stated in detail in the contract. Clients are to read the contract thoroughly and understand what the limitations and investments are.
- All collections will come with a photographer's print release.
- All collections will come with your own private full online gallery.
- Engagement session is refrained to 1 location. Weddings can have multiple locations. If the location you've chosen requires a photo permit and admission fee, clients are responsible for all or any photo permit and other required building payments prior to shooting. Please make necessary arrangements early to avoid getting your session cut short.
- For the engagement session, if you would like to add a few additional high-quality digital images onto the CD, it is \$5.00/image or if you would like the full gallery it is an added \$60.00. If you buy the full gallery for \$60.00, the incentive for this is getting access to digital download. You will also receive the images on a CD

- Choua of Natural Bliss Photography has permission to use photographs compiled during the contracted event on websites or other electronic form or any media, including print and other manner desired.
- No raw or original images will be shown or given out. All the photos in your private gallery are retouched/enhanced and are the final delivered products.
- If you wish to not have the prints included in your wedding collection of your choice, you can subtract \$10.00 from the collection's base price.



- Any additional time added onto the max allowed time in the collection will be \$200/ hour or \$100/half hour. Overtime stay will get billed as an invoice to your email. No photos or images will be shown or given until the overtime charge has been paid in full.
- It is important that you arrive early and on time. I may have other scheduled sessions after yours. If you are running late, I cannot guarantee I can take a variety of photos in the remaining time we have. I may/will need to cut the session short to get to my next session.
- For the engagement session, you can provide your own USB instead if you don't want the CD, but you must provide it on the day of your session. If you'd like to purchase a USB from my service to have your images on it instead of the CD, it is \$20.00 for the USB.
- All the Signature and Wedding Collection prints, except the High School Senior Special Collection, will have the regular print type paper. The Graduate Student Special prints are deep matte and this is what makes it different from the rest of the collections. Although the Regular print paper is just as nice, the deep matte is a more expensive and a higher end quality type of paper. A deep matte print has a smooth/silky texture coat and hides blemishes and noise very well. Message/contact me if you'd like to know more about the two types of prints I offer and what I charge for each.
- All given images on the disk and the prints will not have my watermark on them, unless it is a free printing material product. Any free printing material products will slightly and visibly display my watermark.
- I service the following Wisconsin counties: Milwaukee & Waukesha. If you want your photos taken outside of any one of those counties, a travel fee and other expense charges may apply.
- Cash (must be exact) or Checks are acceptable.
- Turnover rate for completing your engagement photos is typically 1-14+ days, it will depend on my edit workload, backlog, sequence of completed wedding galleries, and peak photo seasons (July – October). 14 is just the average.
- Turnover rate for completing your wedding images is typically 3 months or more. It will depend on my edit workload, backlog, sequence of completed wedding galleries, and peak photo seasons (July – October). 3 months is just the average.
- Your engagement gallery will remain on my website for 14 days (2 weeks) from the date I ship your photo package out to you. After 14 days, there will be no re-upload of your photos onto my website.



- Your wedding gallery will remain on my website for 2 months from the date I ship your photo package out to you. After 2 months, there will be no re-upload of your photos onto my website.
- After your gallery expires (an expiration date will be given to you), there is no re-upload of your photos again. If you'd like me to re-upload your gallery for non-printing order purposes, it is \$100.00 for the re-upload and re-entry access. You will be given full digital download access and un-watermarked images. 1 week is allowed for access before it expires. If you'd like me to re-upload your gallery again because you'd like to order more prints or other photo printing material products, then it is FREE! This will come with watermarked images in your gallery and disabled or non-digital download access and 1 week is the max allowed time for your access before it expires again. For printing needs order by my service, just message or email me your request for re-entry and I'll be happy to provide you this service at no charge. And, just a reminder that any photo printing material products order by my service will not have my watermark on.
- It is *highly* recommended to order your photo printing needs through my service. Please be aware that I am not responsible for prints printed elsewhere by the client. Other printing services may produce poor quality, cause discoloration and inaccurate calibration results of your photos. I do not recommend clients to make their photo prints from their session with me at Walmart, Walgreens and Shutterfly.
- All wedding collections requires a nonrefundable retainer fee to hold wedding date and time. Deposits are due at the time of booking and the remaining balance is due on the day of the scheduled event. Reschedules are permitted and allowed (dates and time may be limited). If client decides to cancel their collection, the deposit it not refundable.
- All the re-touched images shown in clients gallery are AS IS and are the final delivered products. I do not do special edits made by client's request except for making a photo black and white, cropping or flipping a photo of your choice.
- After your session, an instruction letter on how to select your photos and/or prints will be given to you. Please read the letter of instruction thoroughly and carefully as it contains important information about your photos and what the next steps are in receiving your images and photo package.
- **A very important note:** You have 1 month from the delivery of your gallery link and password to submit your list in. After 1 month and you still haven't turned your list in, your gallery will close and will not be accessible for viewing to select your images. You will need to contact me for re-activation, but only 1 week is allowed. After the 1-week deadline, and you still haven't turned your list in, you'll have to repeat the request again in which a different password will be given



each time. Therefore, it is extremely important that you turn your list in in a timely manner so that you can get your photos & photo package in the mail. The reason this is in effect is to hold all clients accountable for their part. I am not responsible to select your images for you, this is a requirement from you when booking a session with me.

- Choua of Natural Bliss Photography is not responsible for any lost or stolen packages or lost or misplaced disk by the client. If clients haven't received their photo package in the mail and the tracking information says it was successfully delivered to their address; in cases like these where the photo packaged could be stolen or misplaced, I can repackage the items again, but a fee will apply. Prices are subject to change at any given time.
